## RULES and REGULATIONS

- 1) **PROCEDURE** –The camp will take place in the locations, period and with the procedure indicated in the programme.
- 2) **PARTECIPANTS** -Beginners and specialization courses are provided for all the sports included in the programme. The participants will be divided into groups according to their age and their different skills, which will be evaluated by the Technical Board.
- 3) **ACCOMMODATION** - The participants will be lodged in the residence halls indicated in the programme, provided with all the necessary services, and where all the theoretical lessons will take place, too, while the practical lessons will be held in equipped outdoor fields, in the gym and in the swimming pool.
- 4) **DEPARTURE** - The participants will have to be present at the time and place agreed for departure, where the transport service is required. Otherway they will be present care of the hotel at 4:00 P.M. of the first camp day
- 5) **REGISTRATIONS** - In order to register, the following documents are necessary: a) registration form b) proof of deposit payment c) medical certificate d) EHIC Card (European Health Insurance Card).
- 6) **REGISTRATION FEE** - It is indicated in the programme. It includes the deposit and is intended per person. The fee does NOT include all the personal extra costs, the telephone calls and everything not explicitly indicated as included in the programme.
- 7) **DEPOSIT** - It is included in the registration fee and it is intended per person. There is no deposit refund in case of cancellation.
- 8) **REFUNDS** - If a registered participant withdraws, the entire fee paid will be refunded with the exception of the deposit, which is non refundable. No refund will be granted in case of: no show at the departure; withdrawal during the camp; inappropriate physical fitness; expulsion from the camp; cancellation notified less than 7 days prior to departure.
- 9) **CAMP RULES** - Any serious infringement of the Camp rules, such as damages to the accommodation or sports facilities, disrespectful behaviour towards instructors and assistants, disruptive behaviour both during lessons and spare time hours, will result in the immediate expulsion of the participant, who will have to compensate the possible damages caused.
- 10) **CANCELLATION** - The Organizer reserves the right to cancel the Camp at any moment, without any obligation except the prompt notice to all the persons concerned, and the reimbursement of the fees already paid.
- 11) **CHANGES** - The Organizer reserves the right to change the programme in case of particular conditions.
- 12) **LIABILITY** - The Organizer shall not be liable for any damage occurred to persons and/or things before, during and after the Camp.
- 13) **JURISDICTION** - The Court of Busto Arsizio shall have exclusive jurisdiction over any legal disputes.
- 14) **THE ORGANIZER SHALL BE LIABLE ONLY AND EXCLUSIVELY WITHIN THE TERMS INCLUDED IN THE INSURANCE POLICY.**  
The particular terms and conditions of the accident insurance policy are the following:  
A) Accidents and limits: Death € 130.000 – Permanent Disablement € 130.000 - Medical Costs Reimbursement € 500.  
B) Deductible percentage in case of Permanent Disablement: equal to 3 percentage points.  
C) Deductible percentage in case of Permanent Disablement caused by accidents happened during Soccer, Karate and Rugby activities: equal to 5 percentage points.  
D) Deductible amount for medical costs: € 50,00
- 15) **HOTEL ACCOMMODATION** - The Organization has the right to settle participants in the hotel facilities. The accommodation in defined on family requests, origins, membership sport society, chosen sport, room availability in the single structure and the acquired priority in the booking list. In case of over booking, the organization has the right to ask to other structures, 2-3-4 star hotel.
- 16) **PERSONAL DATA PROTECTION** - By signing this form, you authorize to handle your personal data you have provided, in accordance with Legislative Decree n. 196/2003 (and its following amendments and additions).
